What does it cost to remain an active member of the body of Dignichat? \$10 annually

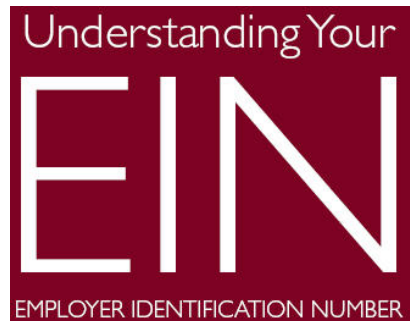


